

## WHERE IS CHANGE LIKELY TO HAPPEN?



#### **NOT LIKELY TO CHANGE**

Color the areas or lots that you don't expect to change for the foreseeable future (20-30 years). No investment expected except maintenance.

## WHERE IS CHANGE LIKELY TO HAPPEN?



#### **SOME CHANGE LIKELY**

Color the areas or lots that you would like to undergo minor changes but will substantively remain the same with minor improvements made on an as needed basis.

## WHERE IS CHANGE LIKELY TO HAPPEN?



#### **MODERATE CHANGE**

Color the areas or lots that you would like to go through major changes such as demolitions, major remodeling, and identify sites for redevelopment.

#### WHERE IS CHANGE LIKELY TO HAPPEN?



Color the areas or lots that are inappropriate for their location, underutilized, deteriorated, or vacant and that you consider appropriate for new significant redevelopment.
